# Minutes of the Remote Meeting of Husthwaite Parish Council held on Wednesday 11<sup>th</sup> November 2020

- 1. **Apologies:** J. Law (ill), County Councillor C. Patmore (attending Shipton PC meeting), District Councillor J. Mortimer (attending another Zoom meeting).
  - Declarations of Interest: None.
  - Ray Alexander has signed the declaration of acceptance of office in the presence of the Chair and completed the registration of financial and personal interests which will be forwarded to Hambleton District Council.
- 2. **Minutes of the previous meeting:** The minutes of the last parish council meeting were approved and signed as a true record.
- 3. Matters Arising:
- 3.1 25 Year Environmental Plan: As JL was not in attendance, there was no update on progress.
- 3.2 Community Right to bid on Husthwaite pub: The PC have heard that the property is under offer and CC will confirm this with Christies. It was agreed that as long as the pub will remain open under new ownership, there will be no need to progress the Public Works Loan option.
- 3.3 Village assistance during Coronavirus lockdown: The PC will continue to collect prescriptions from Millfield and Thirsk Surgeries until at least Spring 2021. Other services such as help with shopping, posting mail and regular telephone check ins are available on request. Lynn Colton keeps in regular contact with OVC members and continues to provide a weekly soup run and monthly meal with her team of volunteers.
- 3.4 Fibre Broadband Upgrade: BS reported that Openreach had received our upgrade application but the estimated cost to connect us with the nearest fibre highway located at North Moor, Easingwold (£900,000 to £1,000,000) means it is unlikely to get the go ahead. Following advice given by Peter Cole from HDC, BS has also made contact with Malcolm Rowe who is collating fibre speed information for our area.
- 4. Matters that have arisen between meetings:
- 4.1 Village Christmas Tree: It has been suggested that Husthwaite erect a Christmas Tree on the Village Green. A committee, led by Sheila Mowatt, is investigating the cost of a 20ft tree with lights and The Orchard Trust have agreed to part fund the project. The PC thought this was a good idea but will need further information regarding the size of tree, method of securing it and type of lights so that a detailed risk assessment can be undertaken, and our insurance company informed. The PC agreed to make a donation of up to £250 towards the costs.
- 4.2 Clerk's Resignation: Jan has unfortunately offered her resignation as Parish Clerk with effect from 11 December 2020. The Council members regretfully accepted her decision and thanked her for all her hard work over the last 5 years. It was agreed that the post would be advertised in the Newsletter and CF offered to undertake the Clerks duties until a replacement is found. Jan will hand over all PC files and inform all agencies to forward correspondence to the Chair until further notice. Action: Clerk

It was agreed that, as the quotation from Tennis Courts Yorkshire was obtained three years ago, CF would ask for an up-to-date quote before a final decision was made. BS reported that Rhys Throup had been raising money for the Royal British Legion by running 11 laps of the MUGA for 11 days in a row - His task was completed today with the whole school in attendance supporting him, WELL DONE RHYS.

Street Lighting: Street light number 3 in Low Street has been reported as not working.

Village Hall: The village hall will remain closed until 2021 due to Coronavirus restrictions.

YLCA: No councillor attended the last meeting. The next meeting is due in February 2021.
