- 1. Apologies: District Councillor J. Mortimer (Westminster).

 Declarations of Interest: None.
- 2. **Minutes of the previous meeting:** The minutes of the last parish council meeting were approved and signed as a true record.
- 3. Matters Arising:
- 3.1 25 Year Environmental Plan: Keith Gittens reported that the AONB had completed a third cut of Kendrew Green recently, due to the grass being extremely long. Unfortunately, they do not have funding for any further cuts this year so CF will ask the grass cutting contractors to undertake the final cut of the season. It was suggested that the draft summary of the Environmental Plan produced by JL should be circulated to all councillors so we can look at ways in which to progress the main objectives. In addition, BS and CF will ask the primary school if we can support them with any planned environmental projects. Action: ALL
- 3.2 Village Green Finger Post: ES has received a quote of £385 for a cast aluminium Village Hall finger post, in the same font as existing, that can be attached to the existing signpost on the village green. The expenditure was agreed, and ES will place the order. Action: ES
- 3.3 **Position of Clerk to Husthwaite Parish Council:** There has been no interest shown to date, so the position will be re-advertised in the next village newsletter. **Action: BS**
- 3.4 **HDC Making a Difference Grant**: Pavescape Sports Surfaces started work on the drain installation and MUGA repainting today. As soon as the project is complete CF will submit the claim to HDC for the MAD grant.
- 3.5 Bier House Roof: The builder who originally inspected the Bier House roof suggested that we request an estimate for the work from Brown Roofing who have submitted a quote for £2650 + VAT. Grant Roofing originally quoted £2630 and, as the estimates are so close, the Parish Council agreed to offer the tender to the contractor who could undertake the work in the shortest timeframe. Action: CF
- 3.6 **Elphin View Traffic Sign:** The No Through Road / No Turning Beyond This Point sign has been erected at the entrance to Elphin View cul-de-sac.
- 3.7 New Model Councillor Code of Conduct 2020: YLCA have still not offered any training sessions with regards to the new Model Code of Conduct so CF will look at the new document to ascertain the changes before the next meeting. Action: CF
- 3.8 Co-option of Parish Councillor: HDC have confirmed that there have been insufficient requests from eligible electors for an election to fill the casual vacancy created by John Law's resignation, so the Council must now take steps to co-opt a qualified person. It was agreed that an advertisement will be placed in the Husthwaite Newsletter and on the Parish Council Noticeboard asking interested persons to apply in writing before the next meeting. Action: CF
